## **THE OAKS CLUB**

### **Rules & Regulations 2026**

#### **Membership Application & Eligibility**

Membership in The Oaks Players Club (“the Club”) is open to individuals aged 18 and older who remain in good standing with San Juan Oaks Golf Club (“San Juan Oaks” or “the Club”). Applicants must submit a completed and signed Membership Application acknowledging these Rules & Regulations. A valid credit card must be placed on file, and full payment is required prior to activation of benefits. The Club reserves the right to verify application information, approve or deny any application at its sole discretion, and issue refunds without interest. Submission of the signed application constitutes agreement to these terms.

#### **Membership Term, Fees & Program Administration**

Membership is valid from January 1 – December 31, 2026 and requires a one-time annual payment. All membership fees are non-refundable, non-transferable, and non-assignable.

Program details, pricing, and benefits are subject to change or discontinuation at the sole discretion of the Club with reasonable notice.

#### **Facility Access & General Policies**

San Juan Oaks Golf Club is open daily to the public. Access to facilities may be restricted during tournaments, private events, or course maintenance. Members and guests must comply with all posted rules and directions from Club staff. Failure to do so may result in suspension or termination of privileges.

**General Conduct & Operations:** Members and guests must conduct themselves courteously and respectfully toward staff and other patrons. Hours of operation may vary without notice. Parking is permitted only in designated areas. The Club maintains a smoke-free environment throughout the property.

**Food & Beverage:** Outside food, beverages, and alcohol are strictly prohibited. All consumables must be purchased through the Club.

**Animals:** Only service animals, as defined under applicable law, are permitted on Club property.

#### **Golf Course Rules & Etiquette**

All golfers must check in at the Golf Shop before play and adhere to standard course etiquette, including proper pace of play, respect for staff direction, and maintenance of course conditions (repairing divots, raking bunkers, and observing the 90-degree cart rule).

Dress code requires collared shirts; denim, gym shorts, and tank tops are not permitted. A maximum of four players per group is allowed, and range balls are for range use only.

Drivers must hold a valid driver's license, and personal golf carts are prohibited.

#### **Tee Times, Cancellations & No-Shows**

Tee times may be booked up to five (5) days in advance. Cancellations must be made at least **48 hours** before the scheduled time to avoid charges. Failure to cancel or appear may result in applicable fees and/or temporary suspension of booking privileges.

#### **Terms & Conditions**

By submitting an application and/or payment, the Member agrees to abide by all Rules & Regulations herein and any additional policies issued by the Club. The Club reserves the right to modify, suspend, or terminate this program or its benefits at any time with reasonable notice.
